


I welcome the initiative by HSA and the National MNCH Program to

In year 2000 Pakistan along with other world governments committed to the Millennium Development Goals (MDGs)eight targets to eradicate poverty and development. MDGs 4 and 5 are specifically focused on child survival, calling for a reduction in child mortality by two thirds and reduction of maternal mortality by three quarters between 1990 and 2015 respectively. Although Pakistan has made steady progress, current levels of reduction of mortality are insufficient to meet the MDG targets. Save the children believes that with determined actions particularly reaching children and mothers from poor and marginal communities, it is possible to prevent these needless deaths every year.


National MNCH and FP conference is one such good opportunity to generate evidence for policy change in order to strengthen health systems and make them equitable and responsive to the needs of the population and address the issues of health financing in Pakistan.

Campaign titled the EVERY ONE Campaign, which aims at addressing under five child mortality. In Pakistan the Campaign is focused on strengthening primary health care, increasing immunization coverage and spreading awareness about preventable causes of death, among other objectives. The movement recognizes that a comprehensive approach to child mortality through tackling inequities is imperative to help make a positive and sustainable change. Unraveling this approach, it means that universal access to essential services, equitable distribution of public resources for child survival and transparency and accountability are the elements which this movement is based on and strives to achieve.

Investment Case in Pakistan

Save the Children has initiated a global In response to growing need for strengthening health systems in Pakistan, to make it more efficient, and equitable to accelerate the progress of MDGs, investment cases approach has been initiated By the Govt. of Pakistan supported by UNICEF and other

development partners. Investment cases demonstrate how health systems may be adjusted to achieve national health and development targets and reach the most vulnerable more quickly and more efficiently. Reducing health disparities to achieve the MDGs with equity is therefore the principal long-term objective for the province and district specific exercises. The medium-term objectives are to support evidence based planning for health and nutrition strategic plans, building planning capacity at district level to strengthen decentralized planning and management for health, increase national and sub national capacities to absorb and leverage funding.

Outcome of completed investment cases can play a significant role in terms of feeding the results in Health Planning process in their district and provinces, that would lead to anchoring the proc-ess of evidence based, decentralised planning and budgeting with an equity focus

Pakistan's Provincial investment case in Punjab ,Sind, AJK and 2 districts of Punjab will provide insight on how to adapt planning processes and health systems strategies to accelerate MDGs 4 and 5 progress, by removing health system bottlenecks and introducing low cost high impact evidence based interventions at different levels of health system.

Punjab District Investment cases are guiding towards decentralised, need based differential planning to reach the most deprived and vulnerable communities, addressing intra district disparities. DICs also help District health teams for appropriate financial allocation and productive absorption of district funds. Several interventional themes emerge clearly from the aggregate

findings of provincial and district Investment cases in Pakistan: 1) Strengthening community-based service delivery, coupled with good referral systems and inclusion of evidence based interventions especially community based maternal and new born care packages, is the most cost-effective way to rapidly expand services among the most vulnerable.

2) Building demand for existing clinical services, particularly preventive and reproductive health services, must be a top priority to increase the efficiency of the overall systems. Effective and strong C4D is the crucial need.

3) In order to build demand, the quality and consistency of primary care and delivery services in particular must improve. Promising strategies include revised and equity-driven human resource policies, task shifting, strengthened monitoring and evaluation systems, standardized and updated (pre-service and in-service) training programs. training programs.
